"You are already probably aware there is now a minus 2 marks by the judge/s that hear a rider using their voice. This -2 mark is deducted from the mark that would have been given for the movement. The best way to handle it is for the judge to give the mark for the movement then cross that out and note the new mark with the 2 marks deducted – eg. 7 cross it out and then put a 5. Need to comment "use of voice" in the comments column so the rider knows why they got a low mark".
